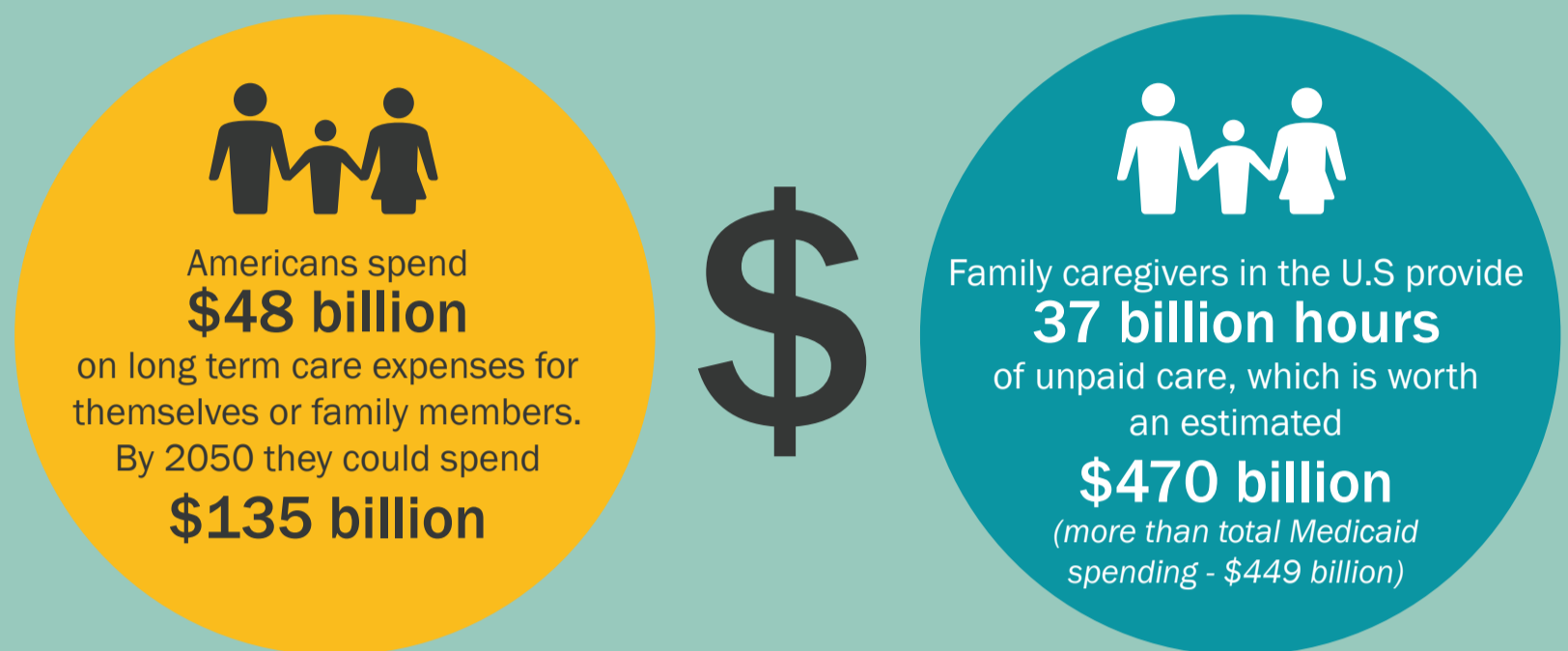
WHO WILL PAY FOR CARE?

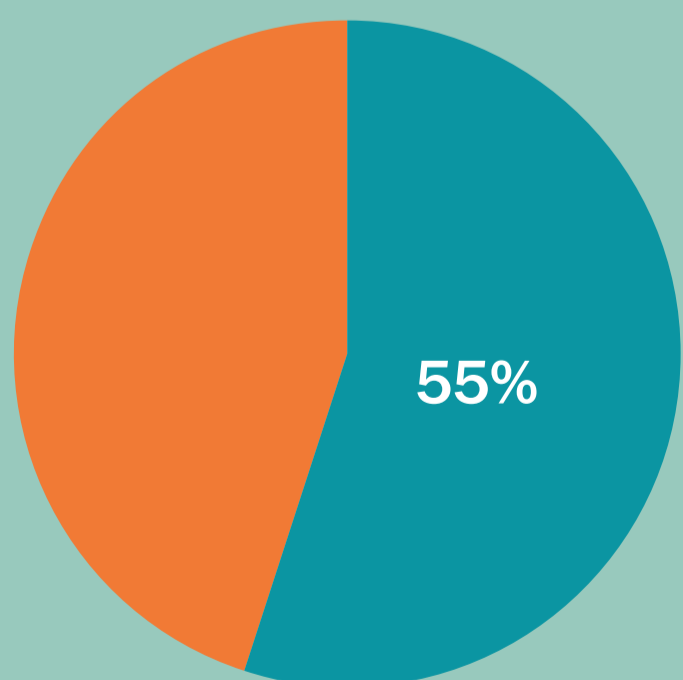
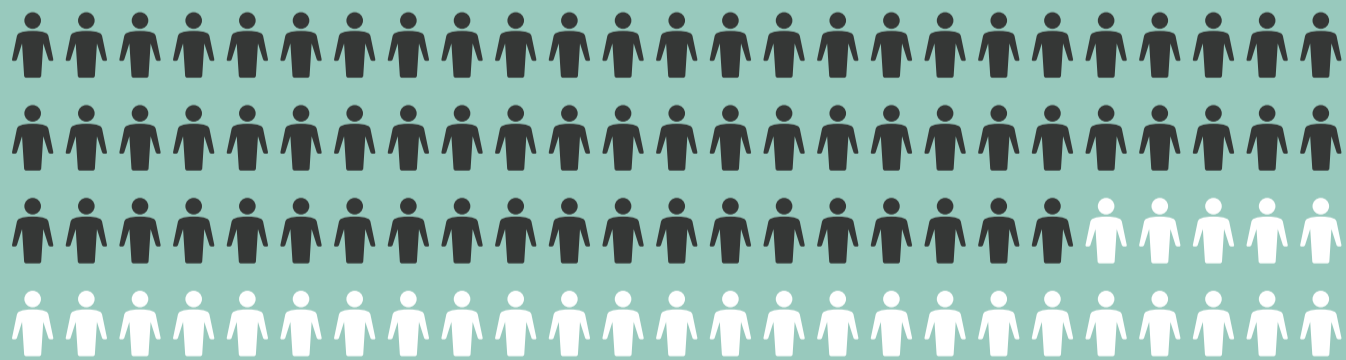

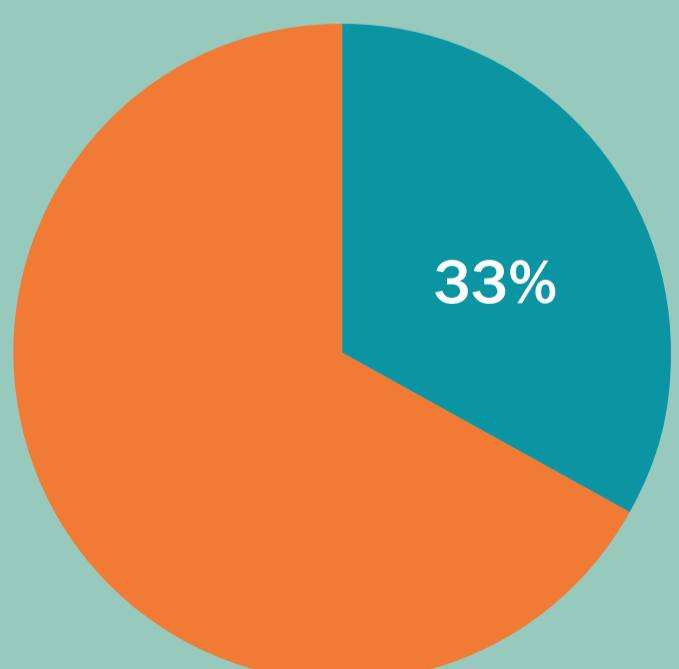


PLANNING FOR LONG TERM CARE
