

# Happy Birthday

A meeting was called at Walther's Hall in Allegheny township (today the North Side of Pittsburgh) on Sunday, February 15, 1890 by our founder Peter V. Rovianek which marked the formal beginning of the National Slovak Society of the USA.

As a result of this charter meeting its Constitution and By-Laws were ratified, goals for the future were set forth and cultural and economic matters were discussed as the society pledged to promote Slovak culture in America. With this emphasis on the economic and social plight of Slovak immigrants in the United States, private voluntary funding was established to provide relief for Slovak workers who became sick or disabled and to help shoulder the burial expenses. An initial death benefit of \$200.00 was set through the \$50.00 donations from four visiting delegates. It was further agreed to pay members a weekly sick benefit.

Finally, by-laws were established for administration and a symbolic seal was adopted.

This first meeting created a safe haven for Slovak immigrants coming to the United States and for those that were yet to come. Little did they know that 123 years later the National Slovak Society would be the oldest, and one of the strongest, Slovak Fraternal Benefit Societies in the United States.

God grant that the spirit of the "Founding Fathers" shall continue to live. In that spirit, the members of our National Slovak Society, as Americans, as Christians, as humanitarians, at all times proud of our Slovak origins, proud of our Slovak ancestry, shall carry on for God, for country, for mankind. We shall go forward to new times, new ways and new successes, ever guiding the footsteps of thousands of Americans of Slovak ancestry along the paths of "fatherhood of God" and "brotherhood of man." # Peter V. Rovnianek Scholarship Fund

The following rules will determine eligibility in applying for a National Slovak Society, Peter Vitazoslav (PVR) Scholarship Grant:

- 1. The applicant must be a member of the National Slovak Society (NSS) for a minimum of two (2) years prior to receiving a PVR Scholarship Grant. Membership will be verified by the Home Office.
- The minimum amount of insurance required for eligibility is \$10,000 of PERMANENT life insurance or \$5,000.00 of annuity deposits. The insurance must be in force at the time of application and be maintained throughout the scholarship period.
- 3. Eligible to apply are all student NSS members whose scholastic records, including College Board Examinations qualify them for acceptance by a college, university (4 years); junior college, nursing, trade, technical or business school (2 years) or other institution approved by the NSS National Assembly.
- 4. All applications must be accompanied by a transcript of the latest high school scholastic record of the applicant. For those already attending college, only college transcripts need to be submitted.
- 5. All applications must be accompanied by proof of the applicant's acceptance as a full-time student by an accredited college, university, junior college, business or trade school. Please list <u>ONLY</u> the school that you are going to attend, not all of the schools that you have applied and been accepted by.
- 6. All applications must be accompanied by a resume or biographical sketch of the applicant, not to exceed two hundred (200) words, along with a recent photograph for publication in the society's magazine.
- 7. All applicants must submit proof of fraternal activity. This activity may be participation in national or local activities, holding elective office in a fraternal benefit society, or similar fraternal involvement. In lieu of fraternal activity, an applicant may substitute community service or volunteer activity with a non-profit organization. (e.g. Hospitals, Red Cross, Juvenile Diabetes or similar charitable organizations.) Applicants must submit verification signed by an assembly officer or by an adult in charge of the community service or volunteer activity.
- 8. No application will be considered unless all requirements are met and fulfilled. Transcripts and all other forms included with the application shall be the property of the PVR Scholarship Fund and the National Slovak Society and will not be returned to the applicant.
- 9. In the event that a PVR Scholarship is granted, it shall be the responsibility of the student to remain in school full-time and to maintain a 3.0 GPA or higher for the remainder installments of the grant to be received.
- The deadline for submitting applications for scholarship grants is MAY 1st of each year. Applications can be obtained from the Home Office or your local assembly. Applications and all required information is to be sent to: PVR SCHOLARSHIP DEPARTMENT, 351 Valley Brook Road, McMurray, PA. 15317-3337. Further information can be obtained by calling 724-731-0094 or 1-800-488-1890.

#### Renewal Applicant Continuation Rules

- Students must submit verification of continuing education enrollment from attending school by submitting a transcript of their grades indicating you have maintained a 3.0 GPA, to the NSS Scholarship Department at the conclusion of EACH school year before they will be considered eligible to receive payment for a second, third, or fourth year grant. These transcripts must be received by JULY 15TH. NO EXCEPTIONS, THIS IS YOUR RESPONSIBILITY. Do not rely on parents, friends, or your agent to get your information in. If your paperwork is not in the home office by the deadline you will not receive a check!
- If you are transferring to another school, you MUST notify the NSS Home Office IN WRITING by sending in an acceptance letter to prove you will be attending a new school full time, by JULY 15TH, BEFORE checks are issued. No renewal checks will be issued after September 15th of each year for any reason.

### **PVR** Scholarships

Attention 2014 Graduating Seniors. NSS is accepting requests for applications for the PVR Scholarships. The scholarship is for \$500 per year for a total grant of \$2,000. Below are the guidelines that you must meet in order to be eligible.

The student must be a member of the National Slovak Society (NSS) for a minimum of two (2) years prior to receiving a PVR Scholarship Grant. Membership will be verified by the Home Office.



### Social Security and You

Since Social Security (SS) was first established in 1939 Americans have relied on this program to help fund their retirement years. The program and the concept are fantastic and have provided millions with security. Fast forward to today and many people worry about the future of Social Security. While the ultimate fixes to SS have yet to be put in place, we hope that our politicians will make the right decisions soon. Subtle changes now will have a tremendous effect on future benefits

No matter what happens you can count on Social Security (SS) to be part of your future. At one-time many financial planners referred to retirement as the three-legged stool made up of (1) Social Security, (2) company pensions & 401k's and (3) IRAs, personal savings, and other assets.

One area that current Social Security recipients are aware of is the taxation of their benefits. New retiree's or people planning on retiring soon should know that at one time SS benefits were tax-free. But times have changed and many taxpayers can now expect that some portion of their SS benefits will be taxed. Above is a basic chart:

Single

Less than \$25.000

\$25 - \$34.000 \$34.000 or more

**Annual Income** 

Less than \$32,000 \$32-\$44.000 \$44,000 or more

% of SS that is taxable

So you can see a couple with a joint income of \$40,000 and interest of \$5,000 would be over the threshold and 85% of their SS may be taxable. It is important to understand this procedure. Any income can

push you into the next tax bracket. For instance: part time income, future IRA withdrawals (especially RMDs after age 70<sup>1</sup>/<sub>2</sub>), interest earnings, taxable dividends, lottery winnings, etc. all have a way of adding to your adjusted gross income and affecting the tax you pay on your SS income.

Some of the ideas to help you minimize SS taxes are: work less, transfer IRA monies to a Roth IRA, or open a Roth IRA. Another idea is to move taxable CD interest to an annuity that is tax deferred. This last point works well especially if you don't need the interest to live on.






Davnejšie tak pracovali naši rodičia na slovensku v zimnych mesiacoch, vyšívali, tkali aby bolo bielizne na celý rok.

### NSS YOUTH ACHIEVEMENT AWARD Rules And Regulations

The National Fraternal Congress of America, through their "Americas Promise" Program, has encouraged their member societies to increase their awareness of the contributions of youth to the fraternal benefit system. In response to that challenge, the National Assembly, in 1998, voted to establish a "Youth Achievement Award" that is similar to our "Fraternalist of the Year Award" for adults. The contest is open to all NSS Youth Members under the age of 21.

**RATIONALE:** The award is directed at youth who do outstanding fraternal work in these four (4) areas: a) At their school/work, b) In their community, c) In their church, d) In their local assembly.

**NOMINATION:** Youth members can be nominated by any adult member of the NSS or through their local assembly. A document detailing the qualifications of the Youth Member being nominated must be attached to this form and submitted to the Home Office. A Youth Member may be nominated each year either until they reach their twenty-first (21st) birthday or until they are selected to receive this award. Nomination forms are available from the Home Office or on our web site at www.nsslife.org under "Forms/Fraternal."

**DEADLINE:** Deadline for nominations to be in the Home Office is April 1st of each year. The winner will be selected by a non-member judge.

**AWARD:** The winning youth will receive a \$500.00 U.S. Savings Bond and will be announced in the "National News", the "Youth Circle Magazine" and listed on our web site at www.nsslife.org under "Youth Achievement Award". Their name will be displayed on a plaque in the Home Office.

**JUDGING:** An independent judge, appointed by the National President, will review all nominations and make a determination of the winner. The National President, or an appointee, shall be the final authority on all matters involving this fraternal benefit.

The winner of the NSS "Youth Achievement Award" will be notified by the Home Office of their selection.
