Christmas Carols and Caroling

In the old world there was a mix of singing and dancing that was practiced for all festivals throughout the year. When Christmas was firmly established to be celebrated on December 25th, many of the existing carols or songs were sung on that day and new ones written to celebrate Christmas.

## 2016 Spring Board Meeting Minutes

The 2016 Summer Board Meeting was opened and called to order on August 13, 2016 by Chairman of the Board Joseph Stefka, Jr at the Home Office in McMurray, PA. After several opening remarks he turned the meeting over to President/CEO David G Blazek for the remainder of the meeting. All Board members and Executive Officers were either present at the Home Office or via teleconference. Also present were: Legal Counsel P. Ronald Cooper, Sales Director Greg Felton, and AQS Asset Managers Byron White and Larry White via teleconference.

All Bond Sales, Exchanges and Purchases through December 31, 2016 were ratified and all Mortgages reviewed. Minutes of the 2016 Fall Board Meetings were approved. The Fraternal Activities Coordinator Report, presented by President Blazek, recapped fraternal events both held and upcoming for 2016.

Sales Director Greg Felton presented the Sales Directors Report highlighting: Sales, Membership, Agent Growth and New Business to date.

Legal Counsel Cooper presented an update on the Power of Attorney/Beneficiary litigation.

2nd Quarter Results were presented by CPA Donald Reddinger, Reddinger, Will, Gallagher & Dickert, LLC. Assets increased to \$974.5M, Surplus increased to \$40.0M, Net Income totaled \$4.1M and Solvency increased to 105.4% (without AVR/IMR).

NSS Asset Manager Byron White, AQS (via teleconference), presented his report, providing information on the state of our Portfolio, Projections on Cash Flow, Crediting Rates vs our Portfolio and Portfolio Yield. Recommended changes to the NSS Investment Policy and Guidelines were reviewed and moved for approval.

Annuity Interest Rates were reviewed and a motion was made to keep the rates the same for the 3rd Quarter of 2016.

Old Business presented the postponement of the Assembly Officers Seminar until March 2017, an update of the NSS Youth Ambassadors Program, the adoption of the new NSS Mission and Vision Statements, a recap of the recent Strategic Planning Session, information pertaining to offering IDShield to our members, and the status of the NSS Cyber Security Policy.

New Business saw the approval of one Petition and the appointment of a new Medical Examiner.

Under Good of the Order, Director Ondrejco provided an overview of what is being planned for the upcoming Septemberfest event on September 24, 2016 at the Home Office, McMurray, PA. Discussion was held on the new National Project "Blessings in a Backpack" and what procedures should be followed for assemblies to support this cause.

## March 2017 Assembly Officer Seminar

Our second Assembly Officers Seminar is being planned for the weekend of March 24, 2017. Beginning with a Friday Fraternal "Movie" night and leading in to the Seminar itself on Saturday, we hope to once again present both a fun and educational event. Details will be provided soon to save the date on your calendars.

## The Christmas Wafers - "Oblatky"

People of different countries of Europe over the centuries have developed their characteristic Christmas customs and traditions, which have become a part of their heritage and life. The people of Slovakia too, have their own beautiful customs significant of their Christian faith. The distribution, at Christmas, of the "Oblatky" (also known as Oplatky) usually by the pastor or by the church deacons, is one such venerable tradition.

The "Oblatky" is an important part of the traditional Christmas Eve and again New Year's Day dinner menu. These dinners are not ordinary dinners, but rather ritualistic and symbolic feasts. It is to be remembered that it is the Štedy Večer – the night of God's generosity and bounty and the "Oblatky" is a symbol or token of God's infinite love in Christ Jesus, His Son.

The day before the Holy Nativity must be quiet, peaceful, and solemn; there must be no hilarity and worldly merry-making; for it's the day of great expectations! And as the "Angelus" bell on the church steeple rings out, the supper begins. The family promptly gathers around the big table, laden richly with many kinds of food, which they allow themselves only on this most holy night.

First the father will offer a fervent lengthy prayer of thanksgiving and blessing, usually reading a prayer for the day from the "Kancional" (the Book of Worship and Hymnal – Tranoscius or Spevnik). Then a couple of Christmas hymns are sung, Cas Radosti or Narodil Se Christus Pán, by the family with mother leading. Worship concluded, the father now distributes the "Oblatky" one to each person; while the mother passes around the honey to be spread on the wafer.

The "Oblatka" (singular "Oblatky", plural) is unleavened bread of flour and water, with figures or scenes of the Nativity impressed on it as it is being baked in the molds. It is somewhat similar to the Communion wafer, only much larger. After the wafer, the father will pour a little wine. Thereupon the mother will serve the traditional sour mushroom soup of sauerkraut juice with rice or barley ("Jucha" or Hubovia Polievka"). Then follows the main courses of meats and vegetables and "Bolbalky" (baked dough served with poppy seed with honey or sugar water); then dry and fresh fruit, figs, nuts, candy, and of course, "Medovniky" (artistically decorated honey cookies), "Kolače" and "Kolačky" (cakes and cookies). A large loaf of home-made bread is

gracing one corner of the table and a bowl of various fruit on another corner, to symbolize God's ever present and ever faithful and bountiful provision.

As in the Holy Communion, the "Oblatka" symbolizes Christ's Body and His Nativity – God's becoming flesh and dwelling with us men (John 1:14); and then offering His Body to be broken on the cross to redeem mankind from sin and death. The word "Oblatka" itself is from the Latin "Oblation", meaning offering or sacrificing. Hence "Oblation" is anything presented or offered in religious worship. The bread we receive in the Lord's Supper is also called "Oblatka" in Slovak.

The honey on the wafer represents the sweet love of God in sending His only begotten Son (John 3:16). The wine is of course symbolic of Christ's Blood. The sour soup is to remind us of Christ's bitter suffering. The entire sumptuous feast is expressive of God's bountiful goodness to men. However, it is the "Oblatka" that is the one significant token or symbol visibly, tangibly and beautifully proclaiming the angelic message:

"Unto you is born this day in the city of David a Savior, which is Christ the Lord...Glory to God in the highest, and on earth peace, good will toward men." (Luke 2:11; 2:14)

## Women and Retirement

A recent retirement survey found that women are far more likely than men to face a financial crisis in retirement. There are several factors that cause this problem. The first is the gender inequality regarding pay. It is still a fact that females make about 80 cents vs a dollar for a male. This lower income affects their Social Security retirement benefits later in life. Another factor is that many women may take time off to raise children. 



Joseph Stefka, Jr. Chairman of the Board

#### December, 1867

Anton Ambrose was born in the village of Kobyle, Eastern Slovakia. He became the second president of the National Slovak Society in 1901.

#### December, 1894

Judge Edwin H. Stowe decreed that the National Slovak Society conformed to the code for the first class of corporations.

#### December, 1907

A disastrous mine explosion occurred in Monongah, West Virginia. Of the 361 miners that perished, 22 were members of the National Slovak Society.

#### December, 1966

A membership campaign was announced to honor National Slovak Society founder Peter V Rovnianek. The winner of the campaign would be awarded \$250 and a championship trophy.

#### December, 1991

The National Slovak Society was mentioned in an article in the current issue of *National Geographic* magazine titled, "Pittsburgh Stronger Than Steel," by Peter Miller.
