2017 Fall Board Meeting **Minutes**

The 2017 Fall Board Meeting was opened and called to order at 9:00 am on November 18, 2017 at the NSS

Home Office in McMurray, PA by Jr. After a few brief remarks he turned the meeting over to President & CEO David G Blazek for the remainder of the meeting. President Blazek asked for a moment of silence in memory of all our dearly departed. All Board members were present along with: Legal Counsel P. Ronald Cooper, Esq.; NSS Sales Director Greg Felton; NSS CPA Donald Reddinger, RWGD; AQS Asset Manager Larry White and NSS Fraternal Activities Coordinator Pam

All Bond Sales, Exchanges and Purchases through September 30, 2017 were ratified and all Mortgages reviewed. Minutes of the 2017 Summer Board

Sales Director Greg Felton presented the Sales Directors Report highlighting: 2017 Sales: Membership and Agent Growth: New Business: and discussion on the new DOL rule. CPA Donald Reddinger presented an Overview of the 3rd Quarter 2017 Financials which showed an increase in Total Assets (\$1.1B), Surplus (\$47.8mm) and Net Income (\$5.1mm) with Total Solvency (less IMR and AVR) at 105.6%. CPA Reddinger presented an overview of IMR and AVR reserves, what their purpose is and how/where they are reported.

The Fraternal Activities Coordinator's Report, presented by Fraternal Activities Coordinator Pam Blum, presented those activities that are coming up in 2018. The 2018 Golf Tournament will be held July 14-15 at Tam O'Shanter Golf Club in Hermitage, PA. The 2018 United Slovak Fraternals Bowling Tournament will be held April 20-21 at Eastway Lanes in Erie, PA and the 5th Annual NSS Night at PNC Park is scheduled for Friday, June 15th. An update of the Fitness Matters and American Hearing Benefits programs was also presented.

NSS Asset Manager Larry White, AQS, presented his report, providing the following: Portfolio Metrics showing Book Yield of 4.69%, Portfolio Quality of A2/A, Effective Duration of 8.4 and Modified Duration of 9.3; followed by a discussion on Buys, Liquidations and NAIC 3+ positions.

A **New Year's resolution** is a tradition, most common in the Western Hemisphere but also found in the Eastern Hemisphere, in which a person resolves to change an undesired trait or behavior, to accomplish a personal goal or otherwise improve their life.

6 Healthy and Realistic Resolutions for 2018

We all tell ourselves that in the coming year we're going to completely stop eating junk food, workout 4-days a week at the gym, and walk to work every day even when it's 8-miles away. However, making health vows that are too big may be the very thing that ruins your efforts.

Experts note that around half of us make New Year's Resolutions, and only 1/2 of that group makes it past mid-January. So, instead of deciding to lose 50-pounds by March, here are six realistic goals that can improve your well-being and that you can build on...

1. Cut Down on Smoking - If you're a pack-a-day smoker, it's probably a lot to ask to cut out smoking completely by February. Cold turkey may work for some, but reducing cigarettes gradually may make it more manageable for you (without the associated rage or grumpiness).

2. Take a Daily Walk - You don't have to sign up for an expensive gym membership to get some exercise, when you have 2-feet and endless pavement outside. If you're finding it difficult to get out of your seat at the office, set aside 15 to 20-minutes of your lunch break to step outside. NSS Fitness Matters walking program could help. 3. Reduce Junk Food Intake - No one said you can't have the occasional bowl of ice cream or a greasy burger, but having them every day might start to add up. If you're biting your fingernails trying to get through a food craving, then the key is to focus on how to deal with the cravings.

4. Have Your Hearing Checked – A study by Johns Hopkins University reports that people with hearing loss are significantly more likely to develop dementia over time than those who retain their hearing. NSS has partnered with American Hearing Benefits so that our members may enjoy the benefits of hearing help at a discounted rate.

Worry Less** - Yes, this can be easier said than done, but a big part of worrying is coming up with worst-case scenarios in our head that probably won't happen. Worrying can be a necessary thing to avoid getting you into a bad situation, but overdoing it will prevent you from thinking it through clearly. Stress can really have a bad affect on your overall health.

6. Celebrate Successes - Instead of changing a bad habit, why not start acknowledging the things you're doing right? We're so programmed to think we're falling short that we forget to give ourselves a pat on the back once in a while when we've achieved something.

PVR Scholarship Applications Now Available

Attention 2018 Graduating Seniors. NSS is accepting requests for applications for the PVR Scholarships. The scholarship is for \$2,000 payable in \$500 installments over four years. Below are the guidelines that you must meet in order to be eligible.

- 1. The student must be a member of the National Slovak Society (NSS) for a minimum of two (2) years prior to receiving a PVR Scholarship Grant. Membership will be verified by the Home Office.
- 2. The minimum amount of insurance required for eligibility is \$10,000.00 of PERMANENT life insurance or \$5,000.00 of annuity deposits. The insurance must be in force at time of application and be maintained throughout the scholarship period.

New Year - New Plan

Have you given any thought to a New Year's resolution? Every January 1st millions of us decide to guit smoking, loss weight, exercise, save more money or something else. These are worthwhile goals and I would encourage you to follow through on your ambitions. The reality of the situation is that most people start with the best of intentions but within a few weeks they slip back into their old habits. Why does this happen? Well part of the reason is that change is hard. We are creatures of habit and like to do what we've always done. So making a new habit becomes tough. Supposedly it takes at least 30 days to form a new habit. Rest assured the vast majority of resolutions will never make it to 30 days.

Here is an old story that Forbes magazine reported on some Harvard MBA students. They were asked to write out their plans. 3% wrote out a plan, 13% had a plan in mind and 84% did nothing. Then ten years later this same group was re-interviewed. The follow up results are staggering. The 84% that had no plan did well and certainly were not starving. However, the 13% that had a plan in mind made twice the money. And the 3% with a written plan made ten times the money.

In Alice in Wonderland, Alice asks the cat which way to go? The cat replies, where do you want to go? Alice says it doesn't matter. And the cat replies then any road will take you there. The point is simple:

It is a proven fact that people who write out their plans or goals do better than those that do not.

So what should you do? First, if you have a goal in mind, make it a SMART goal: specific, measurable, attainable, relevant and timely. Then break it down into little parts because life is a cinch by the inch but hard by the yard. Then read your goal(s) every day and believe that you can do it. A positive mental attitude will work wonders. Then get started now. The law of inertia says that a body at rest tends to remain at rest unless acted upon by an outside force. You are the outside force and must move vourself towards the goal. No one can do it for you – you must step up and take responsibility for your actions.

On your way to the gym think how good you will feel one year from now when your physical health is improved. If you don't do something then one year from now you will be sorry you didn't take action when you first thought about it. Nothing is easy. We have to work for everything – but that is really one of the joys in life. Life is a journey not a destination. Enjoy the trip but at least have a roadmap handy. So make up your mind, get started and take that first step – you'll be glad you did.



Hockey in Slovakia

Slovakia sits in the heart of Europe. Its continental climate means cold winters with snow-covered mountains and frozen lakes, prime conditions for winter sports. So it is not surprising that Slovakia has been involved in the history of ice hockey from the early days, first as part of CSSR*, and now as an independent nation.

The game has its origins in bandy, a game played with a ball instead of a puck. Games of bandy were being played in Bratislava in the early 1900's. Ice hockey, introduced into Bohemia in 1905, began to take hold in Slovakia and by 1929 an Ice hockey Union was formed. In that inaugural season the Slovaks hosted the Tatra cup, now the 2nd oldest hockey tournament in Europe. In 1931, the hockey federation of the Slovaks merged with that of the Czechs, and beginning in 1936 Slovak teams competed with Czech teams for the national championship. During World War II the Slovaks formed their first national hockey team in 1939, and played 10 international games between 1940 and 1944. From 1947 to 1992, CSSR hockey teams collected an impressive 67 medals at international & European tournaments. In 1980 politics and sports crossed paths and changed the game of hockey forever. During a tournament in Austria, the outstanding Slovak players, Brothers Peter and Anton Stastny, defected from the CSSR national team and went to Canada. Realizing that they couldn't prevent the course of events, the CSSR government reached an agreement with the NHL to allow more players to come to North America. This led to other Eastern European nations allowing their star hockey players to leave for the NHL to the point where 17% of the players drafted in 1996 were from Russia, the Czech Republic, Slovakia and other Eastern European nations. With many talented players in the minor leagues, as well as back in the homeland, we are assured there will be a strong Slovak presence in the NHL for a long time. Actually, there are 76 Slovak ice hockey players, who have played in the NHL, there are 9 who are currently playing in the NHL.

By the way if you ever get the chance to look at a hockey puck up close you may see the words "made in Slovakia" along the edge. (* Czecho-Slovakia)

Since 1958/59 76 Slovak defensemen and forwards have played at least one game in the NHL. Also, 4 goalies native to Slovakia have appeared in NHL games. Following is a list of ice hockey players from Slovakia and their teams, who played or are currently playing in the NHL.

How to Make a Wind Vane


What You Need:

- Round plastic drinking cup with lid, or round food storage container with lid
- Pebbles or sand
- Sharpened pencil
- Drinking straw (a straight one, no bendies!)
- Straight pin
- Poster board or card stock paper
- Black permanent marker
- Compass

What You Do:

- 1. Start by putting the lid on the plastic container, and turn the container upside down. Trace around the lid, and then make another circle around the outer edge, at least 2 inches wider than the first one.
- 2. Use a ruler to divide the lid in half along its diameter, and then divide each of those halves in half. Have your child write the words for the four parts of the compass along the outer edge of each of the four sides. Moving from the top, clockwise, she should write "North, East, South, and West."
- 3. Now open the container. Stick a blob of modeling clay or putty on the bottom of the container, and then fill the remainder to the top with pebbles
- or sand. Snap the container lid on and tape it, if necessary, to keep it secure.
- 4. Glue the container, upside down, onto the cardboard compass base you just made.
- 5. Take the sharpened pencil, and poke it through the center of the plastic container so that the eraser is on top, and the point is held by the putty and sand.
- 6. Now, cut a broad triangle and a square, both about 3 inches across from your construction paper. Cut a slit in each end of the straw. Slide the triangle onto one end and the square onto the other. Use a bit of glue if they seem to slip. Push the pin through the center of the straw and attach it to the top of the pencil eraser.
- If you flick the straw, or blow on either end, it should move freely.
- 7. Take your wind vane outside to a place where the wind is not highly obstructed. Help your child find north, south, east, and west on a real compass, and line up the wind vane accordingly. Wait for the next breeze; the arrow will point to where it's coming from.

This Month in National Slovak Society History

Joseph Stefka, Jr. Chairman of the Board

January, 1914

A complaint was filed on January 2, 1914, in the Court of Common Pleas, Pittsburgh, Pennsylvania, against the National Slovak Society by a committee of former officers, trustees, and members alleging that the nomination and election of officers at the XI Convention was unconstitutional and that the delegates had no right to elect officers. The complaint further stated that the election should be done by a vote of all members of the National Slovak Society by mail. The Court later ruled, on November 29, 1915, that the XI Convention did not violate any part of the Charter or By-laws of the Society and that the election of officers prescribed in both documents was correct and just.

January, 1954

First Vice-President Paul Kazimer assumed the office of President following the resignation of President Wendel Platek on December 31, 1953.

January, 1958

Anthylene Blasic of Assembly 815 in Parkhill, Pennsylvania, was named the recipient of the National Slovak Society Scholarship for 1958.

January, 1958

National Slovak Society member, Martin Savol, a senior at Fifth Avenue High School in Pittsburgh, Pennsylvania, was the winner of the first School Science Experts Quiz which was broadcast over television stations WQED and KDKA. The quiz show was sponsored by the Pittsburgh Press, Buhl Planetarium, and the Institute of Popular Science.

SCHOLARSHIP FOR SENIOR MEMBERS A Fraternal Program

PURPOSE ~

To encourage our older members to continue their education and to make fuller use of their leisure time.

MEMBER ELIGIBILITY ~

Any life insurance or annuity member, fifty-five (55) years or older, who has enrolled and successfully completed a continuing education or adult education course. Members may submit up to two (2) applications in one calendar year.

COURSE ELIGIBILITY ~

Vocational schools, community colleges and universities offer a variety of short-term courses which may include areas like computer training, cake decorating, photography, landscaping, small engine repair, ballroom dancing, etc. This program does not cover courses that assist you to maintain your current full or part-time job.

(Example: We will not reimburse life insurance or real estate agents who take continuing education credits to maintain their licenses.)

PROCEDURE ~

Members should enroll and pay for the course of their choice. Once the member has finished the class, they must submit an application, along with verification that the class was successfully completed, to the Home Office for approval by a National Officer. If the scholarship application is approved, the NSS will reimburse one-half (1/2) of the tuition for the course up to, but not to exceed, one hundred dollars.

Zjavenie Pána (Traja králi) 6. január

V tento deň si kresťania po celej planéte pripomínajú sviatok Zjavenia Pána - Troch kráľov. Patrí k najstarším kresťanským sviatkom, ktorý sa slávi od 3. storočia. Jedná sa o deň, kedy sa na oblohe objavila hviezda oznamujúca narodenie Božieho Syna všetkým národom. V minulosti bol tento sviatok spojený s dňom krstu Ježiša v rieke Jordán, ale od roku 1969 sa tento deň oslavuje zvlášť. Ako počas celého vianočného obdobia, tak aj na jeho záver sa viažu rôzne obyčaje. Najznámejšie sú "trojkráľové obchôdzky", počas ktorých najmä mladí chlapci obchádzajú domácnosti, sú zahalení do dlhých bielych košelí a na hlavách majú položené korunky. V každej domácnosti následne predvádzajú trojkráľovú hru - imitáciu návštevy Troch Kráľov pri Ježišovom narodení. Sviatok Troch kráľov sa tiež považuje za záver vianočného obdobia. Najmä v dedinskom prostredí je známe aj koledovanie kňazov so sprievodom, pri ktorom kňaz napíše na dvere iniciálky troch biblických mudrcov - G. M. B. Následné pokropí dom svätenou vodou a zavinšuje zdravie, šťastie a hojnosť.

Folklor—Tradície

Pred vianocami slovenske komunity sa schadzaju ku predvianočnemu stolu na spôsob vigilie aby spoločne slávili slovenske zvyky a tradície. Na snímke súbor Pittsburgh Slovakians ktorý počas oslav zabávaju prítomnych vianočnymi koledami a známou hrou Jasličkari. Toto je azda jedinny súbor v Amerike ktorý hru Jasličkari predvádzaju v slovenskom jazyku.
