

# 2016 Spring Board Meeting Minutes

The 2016 Spring Board Meeting was opened and called to order on June 3, 2016 by Chairman of the Board Joseph Stefka, Jr. at Treasure Lake Resort in DuBois, PA. After several opening remarks he turned the meeting over to President/CEO David G. Blazek for the remainder of the meeting. All Board members were present. Also present were: Legal Counsel P. Ronald Cooper, Sales Director Greg Felton, AQS Asset Manager Larry White and Fraternal Activities Coordinator Pam Blum.

All Bond Sales, Exchanges and Purchases through March 31, 2016 were ratified and all Mortgages reviewed. Minutes of the 2016 Winter Board Meeting (March 2016) were approved.

The Fraternal Activities Coordinator Report, presented by Fraternal Activities Coordinator Pam Blum, recapped fraternal events held to date and those upcoming for 2016. She also announced that the 2016 NSS Fraternalist of the Year is John Bebo, Assembly 0588 and the 2016 Youth Achievement Award Winner is Blaze Farrell, Assembly 0813.

Sales Director Greg Felton presented the Sales Directors Report highlighting: Sales, Membership, Agent Growth and New Business to date. As of 5/5/2016 NSS Membership has surpassed 30,000.

Legal Counsel Cooper presented an update on ongoing litigation regarding a power of attorney (POA) and the authority given to the 'agent' of the POA. Also the need to have POA's forwarded on to legal counsel for interpretation in light of current changes in the law regarding POA's.

CPA Donald Reddinger, Reddinger, Will, Gallagher & Dickert, LLC recapped the 2016 1st Quarter results reviewing AVR, IMR, RBC and the audit reports produced at the conclusion of their annual audit.

The society's Appointed Actuary Edward Cowman, Miller/Newberg, presented his report focusing on cash flow testing and reserves.

NSS Asset Manager Larry White, AQS, presented his report, providing information on the state of our Portfolio, Projections on Cash Flow, Crediting Rates vs our Portfolio, Portfolio Yield and future Asset, Net Income, Surplus and RBC projections for 2016.

Old Business presented discussion of our recent Strategic Planning Session, the review of the NSS Investment Policy, the review of plans for the Assembly Officers Seminar, an update on the status of our Cyber Security Policy, and the introduction of a Board Education and Training Matrix.

New Business presented an overview of Immediate Annuities and their Guarantee Rate by Actuary Ed Cowman and a discussion of current Annuity Interest Rates.

Committee work began with the Assembly Growth committee approving the 2015 Fraternal Tracking report, the Fraternal Allowances and Diamond, Platinum and Silver "extra effort" awards. The Fraternal Growth Committee recommended the approval of Petitions received and the Membership Growth Committee moved to adjust the SPIA Over 10 Years rate to 2.75% from 3.50% and adjust the SPIA Under 10 year rate to 2.00% from 2.50%. All other remaining Annuity rates remain the same.

The remaining committees: Audit, Museum, PVR and Governance all presented their reports.

Good of the Order presented a new National Project called "Blessings in a Backpack" which was approved by the Board.

# Estate Planning and You

You may find this hard to believe but taxes have been around for a long time. In fact, according to the IRS, since the 18th century when a temporary stamp tax was enacted in 1797. A lot has changed since then but taxes are still around. The federal estate tax is somewhat newer and has only been around for the last one hundred years or so. In 2013, the current federal estate tax law was made permanent. For 2016 the exclusion amount is \$5.45 million and the top tax rate is 40%.

Here is how this works. Say you are single and die and you are worth \$8 million. You can leave your children the \$5.45 million but the difference of \$2.55 million is taxed at 40% or \$1.02 million. This amount is due 9 months after the date of death. You may be thinking that this affects only the wealthy but when you add in the value of a home, a business, retirement plans and other assets this could be you too. For most of us this may not be a problem but does that mean you should ignore estate planning opportunities — the answer is NO.

Everyone should have a few basic documents. A will, a power of attorney, a health care directive and possibly a trust. Here are some of the reasons you should have a plan regardless of the amount of assets you own. A good plan will help you with these points:

- Tax-advantages are available with proper planning
- To protect your family's privacy and to avoid probate.

- To minimize the expenses to your estate.
- In case you become incompetent and are unable to manage your own affairs.
- Through a will, you can appoint a guardian for any minor children.
- In case you have family with special needs.
- For blended families do you want your children disinherited because you died first?
- To make special bequests or gifts to certain people.
- So that you can support your favorite charity.
- Do you own a business?

## The Grow Up Plan

The other day one of my associates was talking with her neighbor. The neighbor mentioned that she was looking at one of those offers for life insurance that comes in the mail. She was excited because the plan was for \$25,000 of insurance for her granddaughter, age 1, and only cost \$16.30 per month. # A Slovak Story The White Lady of Levoca

This is an exciting nonfiction story of intrigue and suspense occurring in the now famous city of Levoca. In the early 1700's, Levoca was loyal to rebels led by Ferenc Rakoczi II. The Habsburg forces were unsuccessful in their many attempts to take over the city. Help arrives in the form of Julianna Korponay Geczy (1680-1714). She was encouraged by a huge sum of money offered by the Habsburg forces to help them. She obtained the keys to the front gates and helped the Habsburgs enter Levoca. Julianna's father was loyal to Rakoczi so the rebels had no reason to distrust Julianna. The rebels asked her to deliver some letters containing strategically important information. She instead informed a Habsburg captain of their existence with the hope of receiving more funds. Upon reading these letters, it became apparent to Julianna that delivering these letters put her father in great harm. Rather then delivering these letters, they were burned. When the Habsburg captain inquired about the letters he was told she burned them. Not trusting her story she was arrested and tried as a spy for the rebels. She was subsequently tortured for information then placed in the cage of shame in a white dress. This cage can still be seen today by the Town Hall. She then was finally beheaded. Numerous people have claimed to have seen her walking about town in her white dress after the execution to this day. I personally was in Levoca in 2014, and saw the tile cage, but unfortunately did not view this lady in her white dress. A novel written by Mor Jokai, and many films have been made on this mysterious lady Julianna in her white dress.

A program of memorial services was held at the Bohemian National Cemetery located in Chicago, Illinois to honor Peter V. Rovnianek founder of both the National Slovak Society and the Zivena.

#### October, 1998

The Pennsylvania Fraternal Congress selected National Secretary-Treasurer Paul M. Payerchin, Jr. as recipient of the John Jordan Upchurch Award at its annual meeting held in Philadelphia, Pennsylvania. The award is the highest fraternal honor that can be awarded by the Pennsylvania Fraternal Congress.

#### October, 2001

The National Assembly of the Society approved a "Matching Funds" appeal in support of those whose lives were tragically affected by the terrorist attacks on September 11, 2001.

#### October, 2005

Margaret Pilosi, Honorary President of the First Slovak Wreath of the Free Eagle died. Margaret had served the First Slovak Wreath of the Free Eagle as Youth Director from 1970 to 1980 and as National President from 1980 to 1988.

#### October, 2008

Honorary Director Vincent V. Jacko died. Vince had served the Society as a Director from 1967 to 1982.

The Illinois native capped off his collegiate career with his best season as a Nighthawk, hitting a .341 clip with 15 doubles, 11 home runs and 53 runs batted in. Tidaback sported an impressive .417 on-base percentage and .990 fielding per-


