

#### Johnstown Slavic Festival

From 1880 until 1920, thousands of Slavic immigrants settled in Johnstown, Pennsylvania to find employment in the area mills and mines. By 1920, 25 percent of Johnstowns residents were of Slavic descent. They created a rich network of churches and social clubs to support their way of life and culture. Johnstown went through tough economic times in the 1970's and 80's and many people were forced to leave the community. Johnstowns ethnic organizations suffered. Today, many young people want to know about their ethnic heritage, and the culture and history of their Slavic ancestors.

The goal of the Johnstown Slavic Festival Committee is to create a new program that educates residents of the Johnstown region about their heritage. The plan is to present authentic Slavic music, Slavic folk dance performances, homemade Slavic food, children's learning areas, educational speakers and exhibits, workshops, and ethnic vendors. A full day of entertainment and education is planned for the first Slavic Festival on Saturday, June 13, 2015, from Noon to Midnight in the Heritage Discovery Center parking lots. Admission to the first Johnstown Slavic Festival is free, so mark your calendars and plan on attending this inaugural event in the Johnstown area.

# From the Sales Department...

## The Moment of Truth

In the life insurance business the moment of truth occurs the minute someone dies. From that point on, the responsibility to pay a claim rests with the insurance company. Usually a spouse or children are named as beneficiary(s). Our job is to get the money in the hands of the beneficiary as soon as possible. What you do with the money is not our concern. You might use the proceeds to pay for the funeral, mortgage, car loan, tuition, monthly bills or whatever. It is your money and we trust that you would use it to the best of your abilities

This all sounds great and probably works well when the proceeds are paid to a named beneficiary. But what happens if the beneficiary has passed away. What if the "estate" is the beneficiary? And what happens if children are left as beneficiaries? These scenarios occur every day.

First, if the estate is the beneficiary then we pay the estate and the executor or administrator will handle the distribution of the money according to the will. In the absence of a will the money will be dispersed according to state law and generally follows this formula:

☐ If there is a spouse but no children or surviving parents then the spouse gets everything.

☐ A spouse with one child or children of a deceased child then it is split 50/50.

☐ A spouse gets 1/3 if there are two or more children and the children get 2/3.

Imagine a widow's worst nightmare when her husband dies without a will. Then she finds out that most of his money is in a brokerage account and his mother is the beneficiary. She died a long time ago but he never updated the account to show his spouse as beneficiary. Now the widow gets 1/3 of the account and then the other 2/3 goes to the children but then things get

messy. She must petition the court to become the guardian of the children.

Then she must be appointed as the children's conservator

for their share of the assets. By the way, just because she is the mother and only surviving parent, the court does not have to select her – they could pick someone else, even a complete stranger. Now under court supervision the children's accounts are moni-

tored and controlled. The court will interpret reasonable costs for health, education, maintenance, and support and generally they are conservative. And finally, to add insult to injury, when the child turns age 18, legal majority, they inherit their account. Now you have an 18 year old flush with cash — do you see a Corvette in this child's future? Perhaps, but the question is how many 18 year olds are financially responsible? Here is a simple estate plan that everyone should follow.

☐ Make sure your beneficiary designations are up to date. People die, get married, divorced, change their name, etc. Check and update every so often.

☐ For a few hundred dollars an attorney can make sure your will is up to date. Appoint a guardian if you have minor children.

☐ Set up a power of attorney in case you become incapacitated and you might as well get a health power of attorney so someone can make decisions regarding your end of life care.

☐ Think about setting up a trust for children, special needs situations and/or to protect assets later in life.

☐ Buy life insurance and name a primary and a contingent beneficiary.

## Let's Get Real About College Planning

Lately there have been quite a few stories about too much emphasis being placed on a college education. Trade schools and/or going straight to work in the oil and gas industry is the way to go and maybe so. Obviously that has worked for some.

Here is the reality – the average annual cost of college at a public school is \$15,000 and a private school is \$38,000. The average wages in the U.S. for a high school diploma is \$34,000, college graduate-\$58,000, a difference of \$24,000 per year. The figures speak for themselves. It is also a known fact that students are graduating from college with more debt. It is currently listed at \$1.2 trillion. This means that the average student owes around \$30,000. The payback on this loan has prevented many young people from purchasing a home or car.

Now what can you do about this situation? Save some money, think of college as an investment. You only have so many years and a limited time frame to earn interest. If you save a \$100 a month for 18 years you would have about \$30,000 in a Preferred 8 account. That's a start and this might cover the first year of college. But maybe it's time to start thinking about saving \$200 or \$500 a month. That would generate \$60,000 or \$150,000 over eighteen years. Another step is to save money on a smarter basis. Use tax laws to help you. For instance, NSS offers the Coverdell Education Savings Accounts. You can put up to \$2,000 a year into this plan and if the proceeds are used for higher education than all monies will be tax-free.

Finally, lets' get the children involved. Talk to them about costs, where the money comes from and their options. Statistics show that young people with skin in the game save more early on and have less debt at graduation. The same thing can be said for working part-time while in school. Students who paid a portion of their college costs did better academically, finished school sooner and had less debt than those who had everything paid for them. If you think about it – it does make sense.



## **Annual NSS National Golf Tournament Men's and Women's Official Rules and Regulations**

- 1. The tournament is open to all members and guests of the National Slovak Society and its Youth Circles. There must be at least four Youth golfers officially entered to have a youth class. To protect the amateur standing of these youth, no prize money will be collected from nor paid to them.
- 2. United States Golf Association (USGA) and host golf course rules will govern play.
  - Play ball as it lies. No improving lie.
  - Lost Ball; play from area where ball was last seen and take 1 stroke penalty.
  - Out of Bounds; play from where ball goes out and take 1 stroke penalty.
  - Ball in Water Hazard; drop where ball went in and take 1 stoke penalty.
- 3. Handicaps will be determined as follows:
  - A. All male regular division golfers will play in three flights as determined by handicap. The golfer's first handicap will be determined after he has completed 72 holes of tournament play in the NSS National Golf Tournament. The golfer's handicap will be recalculated every year based on the golfer's best 72 holes in tournament play within the last five years. The handicap will be calculated on a 90% basis. The maximum handicap will be 40 strokes for 18 holes.
  - B. Any male golfer who has not completed 72 holes of tournament play in the NSS National Golf Tournament will be entered in the Callaway division using the NSS version of the Callaway scoring system.
  - C. Senior Men's Division (65 and over) will also play using handicaps as determined above. There will be only one flight in the Senior Division.
  - D. All female member golfers will compete with the handicap determined as above. The maximum handicap will be 40 strokes for 18 holes.
  - E. Any female golfer who has not completed 72 holes of play in the NSS National Golf tournament will be placed in the Callaway division.
- 4. Classifications:
  - A. A medal play champion will be determined for 18 holes and 36 holes in each of the following Divisions:\*
    - 1. Men's A flight
- 5. Women's B flight
- 2. Men's B flight
- 6. Senior flight (age 65 and above)
- 3. Men's C flight
- 7. Callaway Flight
- 4. Women's A flight
- \*Flight handicaps will be determined by number of entries and their handicaps. Champion's for each flight will receive an NSS Jacket, and Prize money. Prize money will depend on the number of participants in each flight. An individual winning his flight in both the 18 hole and 36 hole tournament will only receive one jacket but will receive the prize money for both tournaments.
- 5. In case of a tie for first place in any flight, both in the 18 hole and 36 hole tournament, a sudden death playoff will be used starting on a hole acceptable to the golf course management. If weather or darkness does not permit an actual playoff, a match of cards will be used starting with the number 1 handicap hole and proceeding with number 2, 3, 4, etc. until the tie is broken.
- 6. All other ties will split the applicable prize money. (E.g., two people tied for second will split second and third prize money. Three people tied for second would split second, third and fourth place prize money.)
- 7. The prize list will be determined by the tournament manager using the money contributed by the contestants and matching money contributed by the NSS for all member golfers. As nearly as possible, there will be one prize for each four entries. NSS does not match guest prize contributions.
- 8. The tournament manager will schedule tee times and pairings.
- 9. The Joseph Stefka Sr. Memorial plaque will be awarded to the low net winner of the 36 hole tournament. In case of a tie, the lower handicap will be the winner.
- 10. Golfers with long distances to travel will be given some preferential treatment for Sunday tee times, providing that the scheduling will not disrupt the efficiency of the tournament.

If the scholarship application is approved, the NSS will reimburse one-half (1/2) of the tuition for the course up to, but not to exceed, one hundred dollars.

## PVR Scholarship Renewal Applicant Continuation Rules

#### **Deadline - July 15th**

Students must submit verification of continuing education enrollment from their attending school by submitting a transcript of their grades indicating you have maintained a 3.0 GPA, to the NSS Scholarship Department at the conclusion of EACH school year before they will be considered eligible to receive payment for a second, third, or fourth year grant. These transcripts must be received by JULY 15TH. NO EXCEPTIONS, THIS IS YOUR RESPONSIBILITY. Do not rely on parents, friends, or your agent to get your information in. If your paperwork is not in the home office by the deadline you will not receive a check!

If you are transferring to another school, you MUST notify the NSS Home Office IN WRITING by sending in an acceptance letter to prove you will be attending a new school full time, by JULY 15TH, BEFORE checks are issued. No renewal checks will be issued after September 15th of each year for any reason.
