### Wounded Warrior

Project

Thé Wounded Warrior Proiect currently serves veterans and service members who incurred a physical or mental injury, illness or wound, connected to their military service on or after September 11, 2001. On that date. America watched in horror as approximately 3,000 people died including hundreds of firefighters and rescue workers. Many warriors note a sense of duty to volunteer for the military following this tragic event. September 11th also served as a stimulus for Operations Iraqi Freedom, Enduring Freedom, and New Dawn, Operation Iraqi Freedom refers to military operations in Iraq that began March 19. 2003 and officially ended August 31, 2010. Operation Enduring Freedom refers to combat operations in Afghanistan and other regions in support of the Global War on Terror, Operation New Dawn refers to the conclusion of operations in Iraq beginning September 1, 2010 and ending December 15, 2011.

For the Wounded Warrior Project, there is a distinct difference between

members and alumni. The term alumni indicates a mutual shared experience and denotes your place in the organization. There are no dues to belong to this organization; dues were paid by wearing the uniform and on the battlefield.

I had the personal privilege of meeting a true wounded warrior this past spring at a meeting of the FICs I attended in San Diego California. The warrior I met was a Navy Officer by the name of Kevin Shaeffer who now serves as a Wounded Warriors spokesperson. Officer Shaeffer was stationed at the Pentagon on September 11, 2001. Over 20 of his Navy comrades in his section of the building were killed, but miraculously, Kevin survived the crash. He did suffered burns over 50 percent of his body. To actually hear his story was very emotional. The ironic part of this story is that Kevin Shaeffer grew up and went to high school at Peters Township High which is about 1 mile from the Home Office of the National Slovak Society.

At the recently concluded convention in Hershey, Pennsylvania, the Board had chosen the Wounded Warrior Project as our community fund raiser. Thanks to the generosity of our assemblies, regions and individuals, we raised \$3,000 and made a presentation to the local branch of the Wounded Warriors in Hershey. Thank you to all that donated to such a worthy cause.

#### **AFA** Conference

Last month the Executive Officers, including myself, and several Directors attended the American Fraternal Alliance Annual Meeting in Austin, TX. This meeting focused on Millennials and how to attract them to become active members in the fraternal benefit system. Information gained during sessions will be studied to determine how we can better serve and involve our youth.

### Convention Board Meeting Recap

Members of the Board of Directors met on Friday, June 20, 2014 at the Hershey Lodge, Hershey, PA. All members of the board were in attendance along with Asset Manager Larry White, Sales Director Greg Felton, Actuary Robert Bruce, Actuary Grant Hemphill, CPA Donald Reddinger and CPA Joseph Dickert.

**Investments and mortgages** were reviewed and ratified as was an Internet vote to hold rates for the 2nd Quarter 2014.

## A Bit of Halloween History

Evolving from the ancient Celtic holiday of Samhain, modern Halloween has become less about literal ghosts and ghouls and more about costumes and candy. The Celts used the day to mark the end of the harvest season and the beginning of winter, and also believed that this transition between the seasons was a bridge to the world of the dead. Over time the holiday has transitioned from a somber pagan ritual to a day of merriment, costumes, parades and sweet treats for children and adults.

### Halloween in Slovakia -



In Slovakia Halloween is not celebrated. Instead, on the first day of November, All Saints Day is celebrated.

All Saints Day in Slovakia, as well as many other Slavic countries, is a highly celebrated holy day. Throughout the entire weekend. Slovak families travel across the country to visit cemeteries where their deceased family members are located. Cemeteries overflow with flowers and thousands and thousands of candles are lit and placed on the graves. Families take time to meet together and take care of their family members' gravesites. Because some families must travel to multiple cemeteries across large areas of Slovakia, this begins taking place on Friday and doesn't end until late Sunday night. when the actual observance of All Saints takes place. Virtually all Slovaks travel to their local cemetery late on Sunday night to pay respects and light candles.

#### Ornament Contest

### SCHOLARSHIP FOR SENIOR MEMBERS A Fraternal Program

#### **PURPOSE** ~

To encourage our older members to continue their education and to make fuller use of their leisure time.

#### MEMBER FLIGIBILITY ~

Any life insurance or annuity member, fifty-five (55) years or older, who has enrolled and successfully completed a continuing education or adult education course. Members may submit up to two (2) applications in one calendar year.

#### **COURSE ELIGIBILITY ~**

Vocational schools, community colleges and universities offer a variety of short-term courses which may include areas like computer training, cake decorating, photography, landscaping, small engine repair, ballroom dancing, etc. This program does not cover courses that assist you to maintain your current full or part-time job. (Example: We will not reimburse life insurance or real estate agents who take continuing education credits to maintain their licenses.)

#### PROCEDURE ~

Members should enroll and pay for the course of their choice. Once member has finished the class, they must submit an application, along with verification that the class was successfully completed, to the Home Office for approval by a National Officer. If the scholarship application is approved, the NSS will reimburse one-half (1/2) of the tuition for the course up to, but not to exceed, one hundred dollars.


