A 2020 RMD does not have to be taken this year.



- Any RMD that you have already received may be rolled back into your IRA by 8/31/20.
- COVID-19 withdrawals may have the 10% early withdrawal penalty waived.
- COVID-19 withdrawals may be taxable over three years.

NSS recommends that you consult with your tax or legal professionals to see how these items and others may impact your particular situation.

Why Should I Have An Annuity?

Everyone knows that our annuities are great ways to save money. These timeless programs have been around for quite some time. The key features of an annuity include: tax-deferral, safety of principal, competitive rate of return, liquidity, and probate free passing of assets at death.

Should I have an annuity instead of a traditional IRA or a Roth IRA? The answer is probably no. But what if you already have those, or don't want either of those products.

Then an annuity would work great. A person should have a regular annuity (non-qualified) for several good reasons:

- As a place to put any unwanted RMD money. Many times people with IRAs reach RMD age and don't want to take the money. They have to but with a non-qualified annuity they could put the money there and still earn interest. However, they would still get a 1099 from us for their RMD distribution and owe federal taxes on that RMD amount.
- For any bank CD money that may be renewing at .10% interest. That number isn't 10% or 1% it is .10%. On a \$100,000 CD renewing at that rate you would receive \$100 of interest. Same money in our best annuity would earn more than \$3,000 of interest. That is a big deal!

 How about an inheritance from your late uncle. He left you \$50,000 – now where to put it?

Plus our annuities have a minimum guarantee of 2% interest. They may also be used to provide a life time income stream. In this example, you give up the lump sum and take monthly payments for what could be your entire life. Annuities have so many positive attributes. More people need to become familiar with these savings plans.

The minimum deposit to open an annuity is \$1,000 or \$90 per month. Why not get this plan started now. Call your local NSS representative or Joe Elliott in the Home Office for more information.

Why Should I Have Insurance?

This is a great question and the answer is simple. A person should have life insurance to protect their loved ones. Everyone knows that life insurance can be used to pay for the house, outstanding bills, last expenses, college education and so much more. But there is another side to life insurance. A good example might be the person who starts out buying insurance to protect their family. But later in life when the family is grown the insurance may serve another purpose. Here is an example using some of the columns from our life insurance proposal systems. This information is based on a female, age 35, non-tobacco user, buying a \$100,000 whole life plan of insurance and paying \$868 per year or \$78 per month:

	Annual	Guaranteed	Projected	Death

10	\$8,680	\$4,953	\$5,158	\$101,100
20	\$17,360	\$14,973	\$15,958	\$103,400
30	\$26,040	\$28,797	\$31,450	\$106,400

If she paid her payments for 30 years, she would have paid \$26,040 in payments. If she passed away during that 30 year period, we would have paid the death benefit which is \$100,000 plus the dividends. Here are a few other items for your consideration. What if she quits paying on this policy after 20 years? She has several options; A) she can take the cash (\$15,958), B) she could continue the policy as extended insurance and have \$100,000 of coverage for another 20 years, or C) she could take a paid-up policy for \$42,000+.

What if she keeps the policy for 30 years and now at retirement age; decides she does not want the insurance but would like to have some cash for a safety net. There is \$31,450 available. What if she leaves that lump sum amount with us but decides to take a monthly income to supplement her Social Security. This amount would generate about \$300 per month for the rest of her life.

All of these options exist after the first few years of a policy start date. The longer the policy is in effect the greater these figures or options become. The beauty of life insurance is that it is flexible. It can become whatever you might need in the future. This plan has benefits whether you live, die, or quit paying. No other financial instrument can do as much as life insurance can!



August, 1900

Four National Slovak Society assemblies were founded in August, 1900. Assembly 358, Chester, Pennsylvania, was founded on August 1, 1900. Assembly 359, Traveskyn, Pennsylvania, was founded on August 5, 1900. Assembly 360, Adena, Ohio, was founded on August 19, 1900. Assembly 361, Exeter Borough, Pennsylvania, was founded on August 19, 1900.

August, 1970

The 5th Annual National Slovak Society National Golf Tournament was held on August 1, 1970, at Evergreen Golf Course in Evergreen Park, Illinois, with 22 golfers participating in the event. Mickey Hamalak of Assembly 110 in New York, New York, won the scratch division in the tournament with a score of 79. The winner of the handicap division of the tournament was Tom VanKula of Assembly 553 of Detroit, Michigan.

August, 1994

The 31st Quadrennial Convention convened on August 15, 1994, at the Hyatt Hotel in Pittsburgh, Pennsylvania, with a total of 172 delegates attending. The delegates of the convention named Sophia Hudak, Emily Leo, Joseph Pavlik, and Irene Sippos as Honorary Tribunal Members.

August, 2002

At the 33rd Quadrennial Convention held in Grand Island, New York, the convention delegates named Paul J. Godor as an Honorary Officer and Joseph Tomaskovic, Jr. as an Honorary Director of the National Slovak Society.

The password will need to be at least 8 characters long and will require at least one lower case letter, one upper case letter, one number, and one special character.

As always, we take the security of our member's and agent's information very seriously. We recognize these changes create a slight inconvenience to you, but they are effective countermeasures against unauthorized access to your information.
