Start a Roth IRA right now!

The Roth IRA began in 1998. This program was originally designed to help people save money for retirement. The number one advantage of this program is the possibility of tax free earnings. This can happen if two key rules are followed. One, the account must have been opened for at least five years. The other is the person must be at least age 59½ when withdrawing money.

\$1,600,000,000 - That's a lot of zeros!

That \$1.6 trillion dollars is the amount of college debt we have in the U.S. The vast majority of this money is owned by young people under age 30 either in school or just finished. The average debt per student is around \$30,000 but this depends on where you live. In PA, OH, NY and MI the number is higher and in UT, NV, AZ, CA and FL the average is lower. The debt is growing at a crazy rate of \$3,000 per second or \$10 million dollars per day.

The number of people with some college debt totals 44 million Americans. Believe it or not \$260 billion is owed by people age 50 or older and \$80 billion is owed by people over the age of 60. This senior group not only has to worry about their retirement but also paying off college loans. And a little over \$30 billion or 40% of these loans are currently in default. This cannot be good for a group of people who are living on fixed incomes and trying to keep expenses to a minimum.

Unfortunately the solutions to this problem are complex. There are a lot of factors involved and no easy answers. Parents and grandparents get caught up in this mess by co-signing loans for their children to attend school.

My Slovak Roots

If you have a chance to look at the latest PVR Scholarship recipients' photos, you will see a girl who looks, well, Guatemalan. You may wonder how this Guatemalan-American adoptee qualified for a Slovak-American organization's award. Well, here's my story.

My mom signed me up for Children's Music Academy (CMA) when I was four years old. CMA features ten students at ten keyboards. The program lasts 3.5 years and starts out with strictly ear training. I was a star pupil for the first two years, then homework, erroneously termed "homefun", became a nightmare as my mom would successfully quiz me through flashcards of individual notes, then wonder why I could never identify them when they were placed next to each other on a measure. After months of struggling, I was diagnosed with Visual Processing Disorder. I went through 15 months of therapy while still studying piano at CMA. I just wanted to quit, but my mom bribed me with a trip to Europe, specifically to Slovakia and Austria, if I would push through to the end of the program. I took her up on the offer.

My mom had lived in Austria 20 years prior to this 2008 trip, and had completed a two month work assignment that took her to both Austria and Slovakia in 1998. While in Europe, she had developed friends in both Vienna and Bratislava. The first foreign language my mom ever heard was when her dad used to speak to her grandma in Slovak, the first language for both of them. She has always felt very close to her Slovak roots and wanted to give me the opportunity to see Slovakia from a Slovak family's view, so we stayed with our friends, the Volent's. Mom had promised me that we could ride horses in both countries, as I was a budding equestrian at the time. Marian Volent found a place where we could ride in suburban Bratislava. Much to my surprise, we actually rode in the Western riding style in Slovakia, which is pretty unusual in Europe, as almost everyone rides in the English riding style. I had some experience with both, so I was perfectly happy to ride Western. We were told that the guide could understand English, but we became quickly convinced that she did not understand the word "stop", even though some of the road signs used the English word for that action. We made it back to the stables safely, then headed to Old Town Bratislava for some festivities. It was December, so the Christmas Market was in

full bloom. We enjoyed roasted nuts and cider, then Marian took us on a tour of the town, including a peek at Cumil the Sewer Worker, a sure stop for any tourist to Bratislava. We also visited a few castles in the Bratislava area before heading on to Austria for another horseback ride (this one was English style), visits with friends to yet another Christmas Market, and a trip to the Volksoper (People's Opera) in Vienna to see Hansel and Gretel. When we landed back in Denver, the first words out of my mouth were "where are we going next, mom?"

It's been more than ten years since that trip, but I still sometimes think about what came out of my first real journey abroad. I am grateful that I got to see how important my mom's Slovak roots are to her, as several years later I went looking for – and found – my Guatemalan birth family, and feel more at peace now that I know more about my own genetic roots. 





August, 1909

Four Assemblies were founded in August, 1909. Assembly 630, Clifton Heights, Pennsylvania, was founded on August 7, 1909. Assembly 631, Marianna, Pennsylvania, was founded on August 24, 1909. Assembly 632, Martins Ferry, Ohio, was founded on August 25, 1909. Assembly 633, Carteret, New Jersey, was founded on August 25, 1909.

August. 1974

The 9th Annual National Golf Tournament was held at Hickory Nut Golf Course in Columbia Station, Ohio, with 46 golfers participating in the event. Emil Tomcho and Albert Zbin, both of Assembly 432, tied for top honors in the 80% Handicap Division. Brother Tomcho also recorded the lowest round of the tournament with a 76. John Vorell of Assembly 4 competing in his first NSS Golf Tournament won the Peoria Handicap Division. Susie Gambino and Peggy Joseph tied for first place in the Women's Peoria Handicap Division.

August, 1979

An article and photograph appeared in the August, 1979 issue of the National News, of the first National Slovak Society Annuity being sold to Thomas G. Gmiter at the Society's Home Office.

August, 1990
