The Slovaks of America

(continued from last issue)

The children of Slovak emigrants show eagerness for culture and education and the humble parents have made many sacrifices in order that their offspring might be granted opportunities, denied them in their native land. This is evidenced in recent years by the many young Slovak graduates from American Universities and Colleges, entering from thence all the higher avenues of culture and education, such as legal, medical, scholastic and scientific professions, enabling them to cater to and assist their own people. Great numbers have risen from the menial labor to preside over business and manufacturing enterprises and farming, a credit to their respective communities.

In politics the Slovaks have taken active interest, not influenced, but making same decisions for party and principles. Not satisfied to take the proverbial job of "only the policeman" but have succeeded to seats in City Councils, Mayors of Cities, representatives and legislators of State Assemblies.

The Slovaks of Hungary were virtually saved from destitution, this condition brought on by the Magyarizing attitude of the Austro-Hungarian government toward them in the years preceding the world war. Through the accumulation of earnings, the Slovak emigrants could send aid to these starving families, pay up delinquent taxes, debts on farms and homes and materially relieve all financial jeopardy.

Spiritually and mentally the great mass of the Slovak brothers and sisters and parents left behind in the old country could hardly conceive of their human rights and God offered privileges - that Liberty, Equality, Brotherhood was their birthright. But through those in America, schooled in and enjoying these triune blessings, a marked change happened rapidly. Previous to the world war they were instructed to claim their liberty and despise the tyrant. This attitude was evinced by the Hungarian government and many drastic measures were adopted to check the impetus, but of no avail.

A full consciousness culminated in the awakening of all Slovak colonies of the United States with great enthusiasm at the outbreak of the world war. Setting aside all differences of religion, politics or organization adherence, they stood firmly together on the principle of the Allies: Irrevocably to save the world for democracy. Unreservedly they offered their mites and lives for a victory which meant also the liberation of their brothers. By a union with their closest kin, the Czechs under the name of "Czechoslovakia" they joined hands and emerged from that great conflict a happy, free Republic.

In the Independence Hall in Philadelphia, the Liberty Bell echoed the words of Thomas G. Masaryk that the Czechs and Slovaks declared themselves a free bers Brigid Delien and Cyndi Salat, also and sovereign nation and the great American nation, through its illustrious president, Woodrow Wilson, put on the seal of approval and the Trianon Treaty united the two closest tribes, the Czechs and Slovaks, in one free, sovereign country; "The Czechoslovak Republic."

> This certainly was the greatest achievement of the Czechs and Slovaks of America. Without their moral and financial support, without their sacrifices of money and blood, the "bloodless revolution" of October 28, 1918 in their native land could hardly have been accomplished. The establishment of the Czechoslovak Republic in Europe through the endeavors of their kin in the United States is the greatest achievement of the "Century of Progress"!

Slovak Christmas Fun Facts

- The Slovak Christmas is three days (December 24th-December 26th).
- Christmas Eve (December 24th) is also known as Generous Day/ Generous Evening, and is the most important day during Christmas.
- The main Christmas meal is known as the 'Velija' and consists of 12 dishes (the number of dishes symbolizes the number of Jesus' disciples).
- After dinner, presents are opened on Christmas Eve, and are delivered from Baby Jesus, not Santa Claus.
- Christmas trees are kept up until January 6th (the Feast of the Three Kings).
- The Midnight Mass service is the busiest church service of the year.



Slovak Christmas Eve Mushroom Soup

- 1-2 lbs. onion, chopped
- 1 ¼ cups butter, divided (may need a little more)
- 2 lbs. white mushrooms, finely chopped
- 1 quart water
- 10 (7 ½ oz.) cans sauerkraut juice
- ¼ cup flour
- 1. Sauté chopped onions in 1 cup butter until golden brown.
- 2. Add finely chopped mushrooms to onions and cook until mushrooms are done.
- 3. Add water and cans of sauerkraut juice, bring to a boil, lower heat, and simmer for half hour.
- 4. In a small sauce pan, brown the remaining ¹/₄ cup butter, adding flour to make a roux.
- 5. Slowly add some soup juice to the roux, stirring to blend (about 2 cups).
- 6. Add roux to soup and cook another 15-30 minutes. Serve.

Creating Slovak Christmas Memories

Year after year, we look forward to preparing certain foods, and performing certain activities during the Christmas season. These habits and customs that we consider ordinary, create memories that evolve into traditions.

Slovakia's ancestors are the treasure holders of countless Christmas traditions. Many have lost their meaning in modern times, but others still add beauty and charm to the winter holidays. They are priceless treasures that will help you to feel the warmth, joy and spirit of a truly "magical" Slovak Christmas.

St. Nicholas

On December the 6th, we will celebrate the feast of St. Nicholas. There are far more legends about his miraculous good deeds than there are clear details about his life. Nicholas was quite young when his parents died of the plague leaving him as the sole heir of their vast possessions. He was determined to devote his life, using his inheritance for works of charity. We know that he really did live in the fourth century, that he was the Bishop of Myra (now a part of Turkey), and had been widely honored as a saint since the sixth century. Devotion to St. Nicholas is found in every European country. He became known for his holiness, enthusiasm, and 21 miracles. He is the patron saint of scholars, bankers, sailors, brewers, brides, and robbers among others. Because of his love and charity of the poor as well as the many legends of his good works, St. Nicholas is best known as the patron saint of Children.

In Slovakia, Sv. Mikulaš traveling on foot the evening before his Feastday is accompanied by an ugly chain-rattling devil, and an angel. The angel and devil symbolize the dual forces in a man's nature. Sv. Mikulaš reminds the children that Christmas is a few short weeks away and they must behave themselves or Annette Stefka the baby Jesus will not bring them presents on Christmas Eve. In the morning, Secretary good little children find their boots or shoes which were placed on the window sill the night before, filled with candies, cookies, oranges, apples, nuts or other dried fruits. The naughty children will find a lump or two of coal, or a potato left by the devil. As we honor the memory of this 4th century Bishop, let us remember he is known for his charity and generosity.

Christmas Eve

Christmas Eve is by far the most awaited day of the Christmas season. Sweet aromas fill the crisp winter air. Clean straw is placed under the tablecloth or on the floor to remind us that Christ was bedded on straw in the manger. In some places, the table legs are also bound with chains to represent the link from Christ's birth to his death, and to show the strength of the family. The family sits down to dinner as the first star rises. Blessed candles are lit as a reminder Laurie Fox that Christ is the light of the world. Before the meal begins the house and table President are blessed, using a pine bough and holy water. Oplatky or altar bread, broken and dipped in honey, is distributed to each member of the family. Reminding us of Christ's presence among us-the bread of life. The head of the family then dips his thumb in honey and blesses each member of the household by placing a cross upon the forehead, reminding each to keep Christ foremost in their thoughts and praying that harmony will sweeten their lives. It is also symbolic of the sweetness and bitterness of life in the coming year. Honey is believed to have special medicinal properties, so the remaining honey is placed aside to heal wounds or sore throats during the year. Everyone at the table is expected to have at least a bit of each food, and care is taken that not even a crumb is dropped on the floor. A small bit of each food is also fed to the animals. After the meal, the remaining food is left on the table for the deceased members of the family, whom it was believed, would return as "guests" at midnight. In some villages in Slovakia it was also common to fill a bowl with water and silver coins. After the meal, beginning with the oldest child, they would wash their hands in the money to ensure wealth in the coming year. After everyone washes, the youngest child would keep the coins for good luck.

Food plays an important part in the Slovak Christmas Holiday Tradition.

Each of the foods are prepared for a reason—to symbolize something, for example:

Wine is served to signify the warmth of Christ's love.

The **mushroom soup** is usually made with sauerkraut juice representing the bitter destiny of Christ..to suffer for us.

Bobalky, small, sweet bread balls are mixed with sauerkraut or poppy seed to assure a plentiful crop.

Fish is an important Christmas Eve dish not only because it was considered a fasting meal but also because the scales of the fish resembled coins, symbolizing wealth.

The actual menu, the preparation and the manner in which the Christmas Eve dinner is eaten will vary from village to village and is greatly influenced by religion.

Perhaps this little bit of information will make your Vilija more interesting and meaningful.

Remember --it is up to us to see that these traditions are carried on!

God made Christmas happen; friends make Christmas beautiful; music makes Christmas festive; giving makes Christmas joyous; love makes Christmas complete.

Real Christmas Tree Facts

While they're growing, REAL Christmas Trees support life by absorbing carbon dioxide and other gases and emitting fresh oxygen. The farms that grow Christmas Trees stabilize soil, protect water supplies and provide refuge for wildlife while creating scenic green belts. Often, Christmas Trees are grown on soil that doesn't support other crops.

REAL Christmas Trees are grown on farms just like any other crop. To ensure a constant supply, Farmers plan one to three new seedlings for every Christmas Tree they harvest.

There are about 21,000 Christmas Tree growers in the U.S., and over 100,000 people employed full or parttime in the industry.

It can take as many as 15 years to grow a Christmas Tree of average retail sale height (6 - 7 feet) or as little as 4 years, but the average growing time is 7 years.

This Month in National Slovak Society History

Joseph Stefka, Jr. Chairman of the Board

December, 1907

Jacob's Creek, a small mining village near Smithton, Pennsylvania, was the site of a coal mine explosion on December 19, 1907. The explosion killed 239 coal miners, of which ten were members of the National Slovak Society. The deceased were members of Assembly 125 of Wick Haven, Pennsylvania Assembly 153 of Finleyville, Pennsylvania, Assembly 587 of Meadowlands, Pennsylvania, and Assembly 330 of Pricedale, Pennsylvania.

December, 1959

Assembly 809 of Windsor Hts., West Virginia, announced an Assembly 809 NSS Youth Basketball League consisting of NSS members ages 8-12. Teams representing Beech Bottom, WV, Short Creek, WV, Bethany, WV, West Liberty, WV, and Windsor Hts., WV would compete in the newly formed league.

December, 1966

Grace Sporka of Assembly 588 of Avella, Pennsylvania, captured the Women's Division Title in the Assembly 809 Bowling Jamboree held on December 10, 1966, at the Rose Bowl Bowling Lanes with a total of 669. Grace's score was the highest score in the Women's Division ever recorded in the history of the Jamboree.

November, 1992

District #11 held its Bowling Jamboree at the Surf Bowl on December 2, 1974. Marlene Glass of Assembly 829 of Racine, Wisconsin, won the Women's Division with a score of 604. Steve Taleck of Assembly 829 won the Men's Division with a score of 608.




