NSS SCHOLARSHIP FOR **SENIOR MEMBERS** A NATIONAL SLOVAK **SOCIETY FRATERNAL PROGRAM**

~ PURPOSE ~

To encourage our older members to continue their education and to make fuller use of their leisure time.

~ MEMBER ELIGIBILITY ~

Any life insurance or annuity member, fifty-five (55) years or older, who has enrolled and successfully completed a continuing education or adult education course. Members may submit up to two (2) applications in one calendar year.

~ COURSE ELIGIBILITY ~

Vocational schools, community colleges and universities offer a variety of short-term courses which may include areas like computer training, cake decorating, photography, landscaping, small engine repair, ballroom dancing, etc. This program does not cover courses that assist you to maintain your current full or part-time job. (Example: We will not reimburse life insurance or real estate agents who take continuing education credits to maintain their licenses.)

~PROCEDURE ~

Members should enroll and pay for the course of their choice. Once the member has finished the class, he/ she must submit an application, along with verification that the class was successfully completed, to the Home Office for approval by a National Officer. If the scholarship application is approved, the NSS will reimburse the full tuition for the course up to, but not to exceed, one hundred dollars (\$100.00)



There must be at least four Youth golfers officially entered to have a youth class. To protect the amateur standing of these youth, no prize money will be collected from nor paid to them.
- 2. United States Golf Association (U.S.G.A.) and host golf course rules will govern play, except the following:
 - Jungle Golf, improve lie within 12" except in hazards.
 - Lost Ball; play from area where ball was last seen and take 1 stroke penalty.
 - Out of Bounds; play from where ball goes out and take 1 stroke penalty.
 - Ball in Water Hazard; drop where ball went in and take 1 stoke penalty.
- 3. Handicaps will be determined as follows:
 - A. All male regular division golfers will play in three flights as determined by handicap. The golfer's first handicap will be determined after he/she has completed 54 holes of tournament play in the NSS National Golf Tournament unless golfer has a U.S.G.A. index from their home course. The golfer's handicap will be recalculated every year based on the golfer's best 54 holes in tournament play within the last five years. The handicap will be calculated on a 90% basis. The maximum handicap will be 40 strokes for 18 holes.
 - B. Any male golfer who has not completed 54 holes of tournament play in the NSS National Golf Tournament will be entered in the Callaway division using the NSS version of the Callaway scoring system, unless they have a U.S.G.A. index.
 - C. Senior Men's Division (65 and over) will also play using handicaps as determined above. There will be only one flight in the Senior Division unless the number of participants warrants 2 divisions. Forward tees will be used.
 - D. All female member golfers will compete with the handicap determined as above. The maximum handicap will be 40 strokes for 18 holes.
 - E. Any female golfer who has not completed 54 holes of play in the NSS National Golf tournament will be placed in the Callaway division.
 - F. Junior Golfers will use the NSS version of the Callaway Scoring System. Forward tees will be used.
- 4. Classifications:

A medal play champion will be determined for 18 holes in each of the following Divisions:*

- 1. Men's A flight
- 3. Men's C flight
- 5. Women's B flight
- 7. Callaway Flight

- 2. Men's B flight
- 4. Women's A flight
- 6. Senior flight (age 65 and above)
- *Flights will be determined by number of entries and their handicaps. Champion's for each flight will receive an NSS Jacket, and Prize money. Prize money will depend on the number of participants in each flight.
- 5. In case of a tie for first place in any flight, a match of cards will be used starting with the number 1 handicap hole and proceeding with number 2, 3, 4, etc. until the tie is broken.
- 6. All other ties will split the applicable prize money. (e.g., two people tied for second will split second and third prize money. Three people tied for second would split second, third and fourth place prize money.)
- 7. The prize list will be determined by the tournament manager using the money contributed by the contestants and matching money contributed by the NSS for all golfers. As nearly as possible, there will be one prize for each four entries.
- 8. The tournament manager will schedule tee times and pairings.
- 9. The Joseph Stefka, Sr. Memorial plaque will be awarded to the men's low net winner of the 18 hole tournament. In case of a tie, the lower handicap will be the winner.
- 10. Golfers with long distances to travel will be given some preferential treatment for Sunday tee times, providing that the scheduling will not disrupt the efficiency of the tournament.

2025 Youth Achievement Award Winner Maya McDonnell



Maya has been a lifetime member of Assembly 617, participating and helping with Fraternal Day at Knoebels Grove almost every year. Not being much of a poet, she has submitted several works for the art and ornament contests and even won once or twice!

Maya is an active member of her church of St. Matthew's. She first helped the parish as an altar server for six years and now teaches religious education to kindergarten and first graders in her last two years of

high school. She also participates in seasonal decorating of the church and classrooms, Letters to Santa, and serving at Community Meals. This year she won the annual Bishop's Youth Award, given to 8th and 12th graders, nominated by the parish pastor. These youth have demonstrated "actively pursuing the four pillars of word, worship, community, and service."

In her neighborhood in the Pocono mountains, it was Maya's idea for her family to host high school international exchange students. The first was for six months with a student from Germany with Youth For Understanding. The second was for two weeks with the German American Partnership Program. Her family also hosted children form the Fresh Air Fund for many summers. This program matches youth from the inner cities of the New York metropolitan area with families from "the country." Perhaps that is why Maya was open to the joy (and challenges!) of sharing their home and lives with strangers. Whether the students came from Queens or Kaiserslautern, Maya tried her best to help them feel part of the family, school, and community. As a testament to their continuing friendships, she has been invited to visit these student's families and has already purchased her ticket to Europe after graduation.

Hopefully travel plans can include Slovakia!

She assists neighbors in feeding and walking their pets (except for the fish) and watering their plants. She even started her own micro business called "Got Gardening?" Once she could get her working papers, she was first employed at a local ice cream shop and cafe for a year and a half and now has been working for over a year at Great Wolf Lodge as a food and beverage attendant.

Maya is a very busy senior at East Stroudsburg South High School. She has been playing in the band since the third grade, but it was in high school that she switched from trombone to tuba. She has played with the Tri-County and District Bands, and this year, Regional Band. All of these require multiple auditions, time away from home and school, and a certain amount of discipline to make amazing music with musicians from many different high schools. She is a member of DECA, an international career and technical high school student organization. She attended one of their conventions in Hershey, PA, and twice won awards in the Hospitality and Tourism category for her yearly presentations.

For the past four years, she has been active in the Four Diamonds Mini-THON, which raises funds to support children and their families struggling against childhood cancer. This year she is in second place for fund-raising so far! Throughout her high school years, Maya has earned her place in the National Honor Society by staying in the top ten percent of her class and serving as its Activities Coordinator. In addition to taking honors and AP courses, she has earned credits for future college courses. She has also received several Student of the Quarter and Music Department awards.

This past year, Maya is a member of the Future Educator Cohot, a pilot program to introduce high school seniors to a career in education. They are paired with veteran teachers in the area and have weekly visits with different schools and grade levels. She was also instrumental in creating a video for younger grades to learn about the Cohort. As senior vice president, she has been active in fundraising, decision making, and advocating for the Class of 2025. She is very involved in after-school sports, late summer through late spring, as a team captain for both the cross country and track and field teams, often placing in the 4x800 relay, 1600 and 3200m races. Last year, her times qualified her for track and field Districts and Eastern Pennsylvania Conference.

2025 Fraternalist of the Year Iim Bench



A retired professor from Indiana University of Pennsylvania, James M. Bench, or Jim as he prefers, has spent a considerable portion of his life helping others. When asked why, his response is consistent, explaining that his Slovak grandmother had always insisted that he help others, especially Slovaks.

A proud United States Army veteran, he became active with the Blairsville VFW, participating in the annual community fair as well as other post activities including play-

ing on the VFW fast pitch softball team. His community activities continued to accelerate especially following his return to Pennsylvania after a short absence. In the small community of Derry, PA, Jim became actively involved in the annual church fundraising fair as well as donating prize vegetables from a prolific garden. Coaching Little League and Teener League Baseball also became a priority and lasted for many years.

A chance meeting with a young Slovak exchange student returning to Slovakia after a year in the USA revealed that she had no idea of Slovak/American organizations or Slovak/Americans. This led to the immediate development of the "Bench Slovensky Den" or Bench Slovak Day held in their residence in Derry, PA. Slovak exchange students were invited to the affair. Transportation was provided, as was much food and merriment. The presence of an honored guest, such as an important elected official, prominent entertainer, fraternal leader, or Slovak embassy diplomat led

to situations of great advantage for many of the students. The Bench Slovensky Den continued for over 10 years, end- included helping Slovaks interested in immigrating to the ing when privacy regulations made it too difficult to identify the Slovak students. However, the many positive results were long lasting. There was no organizational support, and the associated costs were absorbed by the Bench Family. Another project was the clothing shipments to the mostly Slovak smaller villages. Another project was the clothing shipments to the mostly Slovak smaller villages. Under an arrangement with a large department store, seasonal clothing was available at dramatically reduced prices. The cost of goods and shipment were borne by Jim and his wife Kay.

In the interim, Slovak Folk and entertainment groups were finding their way to the USA. Unfortunately, some were ill advised relative to the size of the USA and associated costs such as travel, food, and accommodations. A tremendously talented family of eleven, which included nine children, along with parents visiting western Pennsylvania stayed with the Bench Family for over a week. Their stay included assistance with contacting and scheduling performances along with transportation to the performance sites. Another group of forty were fortunate to have had an entire weekend of food prepared and delivered by the Bench team of Jim and Kay. Other groups were accommodated and also assisted with finding entertainment sites in order to perform and earn money.

Steve Bacon, who founded the Youngstown, OH, Spisska Nova Ves Sister City Program was persistent in inviting Jim to join the program as a board member. Friendly persistence from Steve Bacon and Judge John J. Leskovyansky, followed by a phone call, advised Jim of his selection to the Board. Although the selection was without application, it led to a very active schedule lasting over two decades. During that time, Jim served as Director, Vice President, and ultimately President. The numerous activities of the Youngstown Sister Cities Program would rival any existing programs. Programs include a survey with Spisska Nova Ves that resulted in a request for teachers of English. Our response was forty-two teachers of English in 1991-1998. A major program of medical supplies and equipment was one of the major projects. The value of the shipments exceeded \$15 million. Most of the equipment came from closed Veterans Hospitals in the Ohio area. Financial assistance to pay for a pump used to contain flooding by the fire department was appreciated, as was financial assistance in establishing an emergency warning system throughout the city.

Following the dramatic and highly damaging hurricane in the Tatra Mountains, funds were donated to replace trees that were destroyed. With the kind assistance of a local business, numerous shipments of beautiful evening gowns have been a major activity with the amount of formal wear in the thousands. To support these endeavors, fundraising is a major activity and the Slovak Fraternals have been generous and gracious in responding to our requests.

The annual Tour of Slovakia is a program that entails time, effort, and an abundance of patience. The total of 21 tours with 596 tourists would ordinarily require a Tourist Agency. However, the tours originally initiated by Steve Bacon were eventually entrusted to Jim and Kay Bench. In addition to a highly attractive tour of Slovakia, assistance was provided to families searching for relatives, some with little or no contact in 100 years.

The Bench activity program over the years has also USA, and providing the sponsorship required. The activities of the Sister City program not included in this report are available to the interested parties.

Finally, as a proud Veteran, Jim is a life member of the VFW and also belongs to most of the Slovak Fraternals, including NSS Life. He takes solace in looking up to heaven and stating. "Bubba, I tried."

A huge thank you to all the members of Assembly 731 who made our special project possible.



Scholarship for Studying Slovak at the University of Pittsburgh

The University of Pittsburgh is the only university in North America offering a minor in the Slovak language and culture. In order to help sustain the Slovak Program, National Slovak Society member Professor Michael J. Kopanic, Jr. has funded a permanent scholarship for students who are studying advanced Slovak at the University of Pittsburgh.

Beginning in the 2025-2026 academic year students currently studying Slovak courses in the Department of Slavic Languages and Literatures are invited to apply for the Michael Kopanic, PhD Fund Scholarship. Eligible

recipients must be in good academic standing, currently enrolled in a Slovak course, and have committed to taking Slovak course(s) within the next academic year.

Michael J. Kopanic, Jr. is an Adjunct Professor of History at the University of Maryland Global Campus (UMGC) and a former editor of Jednota, the publication of the First Catholic Slovak Union. He has earned degrees from Youngstown State University (A.B.), the University of Notre Dame (M.A.), and the University of Pittsburgh (Ph.D.). At UMGC, Professor Kopanic has served as Course Chair and Course Coordinator for European history courses and received an outstanding teaching award in 2012. He also administers three Facebook sites: Learning the Slovak Language and Culture, Slovak History, and the Slovak Studies Association.

Professor Kopanic has contributed numerous articles to the former NSS National Almanac, the NSS Year in Review and other Slovak-American publications, Naše rodina, and many academic publications, and edited the books Slovaks in America and Illustrated Slovak History. A former Czechoslovak Genealogical Society International board member, he serves on the Academic Committee of the Museum of Slovak Emigration to North America, is an academic consultant for Global Slovakia and is on the editorial board of the journal Kultúrne dejiny (Cultural History, Ružomberok, Slovakia). He is currently working on a book about Slovak traditional customs.
