RULES & REGULATIONS

Part 1

On _____ We anticipate _____ NSS members will participate.

We request that a donation from the NSS Fraternal Activity Fund Program be allocated on our behalf.

We understand that we must abide by the following rules to receive this fraternal donation:

1. This event **MUST BE ADVERTISED** in the "National News" at least thirty (30) days prior to and again at the conclusion of the event. A fraternal payment of **\$6.00** per NSS member who attended and signed the Part II "Sign-In-Sheet" will be eligible. Only NSS members are eligible. The maximum per fraternal event is **\$500.00**.
2. Only **ONE (1)** such event shall qualify for payment to any NSS Assembly/Circle/Region on any given day.
3. The fraternal donation will be made at the conclusion of the event when the Fraternal Fund Activity Form is returned to the Secretary-Treasurer/CFO with signatures of the NSS members who attended. This form **MUST** be signed by an officer. Members **MUST** clearly sign their own names.
IMPORTANT : Both Part I and Part II (front and back) of the Fraternal Fund Activity Form must be filled out to be eligible for the fraternal funds.
4. Assembly/Regions are permitted to hold a YOUTH-Specific fraternal events to gain additional funds for their Circle. This YOUTH-Specific fraternal event must be held benefiting the youth. **\$3.00** for each youth member attending will be reimbursed. Adult members will earn **\$6.00** for accompanying their youth to the event.
5. Fraternal events organized by an Assembly/Circle/Region eligible for this fraternal donations are : picnics, dances, parties, socials, bus tours, senior citizens events, ect. **Regular Business Meetings are NOT eligible.**
6. Activities held together with a Matching Funds Project are NOT eligible for the Fraternal Activity Fund Program.
7. A fraternal event held by an Assembly/Circle/Region will qualify as a meeting and counted towards the **four (4)** Assembly Meetings/Events or **one (1)** Region Meeting/Event required each year.
8. Regions shall be eligible for funds for their treasury for events held provided that events are held for members of both their Youth Circles and their Adult members.
9. Regions shall be eligible for funds for their treasury for events held provided that events are held for members of both their Youth Circles and their Adult members.

Members MUST clearly sign their own names.

Both Part I and Part II of the Fraternal Fund Activity Form must be filled out to be eligible for the fraternal funds.
